Dear Judge Failla,

We write on behalf of Defendant Pfizer Inc. (“Pfizer”) in the above-captioned matter to request an extension of time for the Settlement Administrator¹ to cause Notice to be disseminated to Settlement Class Members to allow the Parties additional time to review and approve the final Notices, Claim Forms, Settlement Website, and other relevant materials.

Per Your Honor’s Order granting Plaintiffs’ Motion for Preliminary Approval (ECF No. 133), the Notice Date is currently June 29, 2026. The Parties respectfully request a two (2)-week extension of this deadline, such that the Notice Date would be July 13, 2026. The Parties also request that all subsequent dates be extended by an equivalent amount, as summarized in the chart below.
